Meeting called to order by Stephen Costello. Stephen Costello welcomed everyone and introduced the board.

Meeting minutes from 10/8/13 were approved .

Treasurer's Report: \$149.00. There were no transactions in the last month.

Reports/Old Business:

Roseville Police Officer: Officer Dan Stokes attended the meeting. We have not had activity in our area in the last few weeks. The officers from the Sammy Duran incident are doing well. The officer with the jaw injury will have a long recovery. The incident showed how well the city responded along with neighboring law enforcement to help when needed.

The sound wall per Officer Stokes is in a state of blight. Officer Stokes has been working with the city trying to figure out a solution for the 8 ft. high and 2000 ft. long sound wall. He talked to street and park and maintenance departments; they were very hesitant due to the cost. It would cost thousands of dollars to repaint the wall. Officer Stokes said possibly a shared cost could be worked out to get the wall painted. Some ideas are to possibly use as an Eagle Scout project or get the paint donated and get a painting crew of neighbors to paint. The wall is part of the streets department. Ask for capital improvement with city, because they would have to budget and it may take quite a long time. The paint for the walls is recycled paint and that is why the graffiti that is covered is different colors. It was asked of Officer Stokes if we could get a budget breakdown of paint and labor from the city. By spring time hopefully we can get started on the sound wall improvements.

Hidden Hills signs - were put up by the city. The city will not provide signs currently. Possibility of fundraising. The city can make signs if we fundraise for the signs, however they would look like city signs and not decorative

neighborhood signs. Park & Maintenance may be able to find the template. It was also discussed to just remove the signs because other additions in our SCNA do not have signs depicting their additions. We may need to send a few letters to the city council and city manager's office to get the walls better maintained.
