### **Reports/Old Business**

Roseville Police Officer Neighborhood Report: Officer Stokes mentioned a scatter of activities in the area such as mailbox tampering, drunk driver using whippets, daytime burglaries and fake jewelry scams. The Roseville PD Gang Suppression Unit has temporarily been assigned to patrol since the PD is currently short on patrol officers. All patrol officers are able to handle gang situations and it remains a high priority.

**Sound Wall Update:** Officer Stokes hopes to bring a City official to an upcoming meeting to discuss the sound wall. The signs on the Hidden Hills entrances are glued, bolted and contain graffiti. It was mentioned to inquire if there was a contractor in our neighborhood who could help with the signs and wall. Colleen said RCONA had talked about neighborhood designation signs along with street signs at major entrances, but the possible project has not been mentioned recently. Colleen contacted a Boy Scout Troop in Granite Bay to see if one of the Scouts needs an Eagle Scout project. At this time, her call has not been returned. It is a long term project.

**Newsletter - Digital and Paper:** Dave McGovern had talked about doing a monthly digital portion. Our goal is to deliver a paper newsletter four times a year.

**Website - Progress and Contributions:** Colleen and Marilyn need help. Colleen will email Loren Cook to see if he will help further since the website is a high priority for communication with our neighborhood.

**Meetings - Determining Type and Frequency - Focus on Growing Involvement:** We need to offer socialization and advertise meetings. Offering something of value may get people interested in being involved. Movie in the Park, National Night Out and Elections are the three big social events.

**Elections:** Annual elections will be the June meeting date.

**Neighborhood Watch Program and Meeting:** Colleen and Marilyn reviewed the neighborhood map and identified addresses of the neighbors that expressed interest in being block captains. Other addresses were identified as possible block captains, but we have not contacted them yet. We need to give direction to our volunteers so they can become designated neighborhood watch areas with the City.
