South Cirby Neighborhood Association Meeting Minutes

Tuesday, September 10, 2013 7:00 p.m. Crestmont Multi-Purpose Room

Meeting called to order by President, Stephen Costello at 7:00 p.m.

Present: Officer Dan Stokes, Dave McGovern, Colleen Cole, Stephen Costello, Joe and Helen Dorr, LaRon Golden and Steven Foley

Secretary's minutes from last meeting will be submitted electronically and approved later.

Treasurer, Colleen Cole, reported an ending balance of \$149.00. RCONA refunded our National Night Out expenses of \$91.74 and we had an expense of \$41.00 for the cost of the 41 KKAD25 signs we purchased from RCONA.

Updates

Officer Stokes' Neighborhood Update: Door kicking in has stopped since a man was arrested a second time for this crime. Officer Stokes' advice was to keep porch lights on and garage doors closed. If we notice a crime, he asked that we be a good witness and call the police. Steven Foley asked how communication from the police department in urgent situations is handled. If the police need to alert neighbors, they can use a phone system or a helicopter announcement.

August 15 RCONA Meeting: Colleen mentioned Roseville's new Town Square on Vernon Street has ongoing events. Check the City's website for more information. The Friday Flicks should not conflict with RCONA's Movie in the Park.

Action: Marilyn Floyd will provide notes from this meeting next month. RCONA minutes are available on their website.

Neighborhood Watch/Block Captains: Colleen reported that Annette Gillespie prepared a block captain spreadsheet with 20 volunteer names. Annette would like to know when to request a Neighborhood Watch meeting. Colleen suggested that even though the block captain list is small, we should move forward and keep Neighborhood Watch a high priority. Steven suggested a separate meeting from our regular monthly meeting. The Roseville Police Department conducts these meetings on Monday, Tuesday or Wednesday from 6:30 to 7:30 p.m. and they will pick the date from our proposed dates of October 7, October 14 or October 16.

Action: Annette will request the Neighborhood Watch meeting and when the date is chosen by the Roseville Police Department, contact everyone on the block captain list to inform them of the meeting. Place for the meeting is to be determined.

South Cirby Sound Wall Graffiti and Paint Condition: Colleen shared photos of the sound wall. She has been unable to get a reply from the City regarding who is responsible for maintaining the wall. Phone calls to the graffiti hotline have not been

returned so that may not be the correct department for this concern. Officer Stokes will email Colleen when he learns what department would be able to help us, possibly the Streets Department.

Action: Colleen will continue following up on this neighborhood concern.

Keep Kids Alive Drive 25 Signs: RCONA gave SCNA 15 replacement signs because some of the signs we sold are not sticking to the garbage cans. If anyone has a problem with their sign, ask Colleen for a replacement while the limited supply lasts. RCONA will update us when new signs are approved by the City.

Website: Marilyn, Colleen and Cheryl Small attended web page training from Loren Cook (RCONA) using WordPress. SCNA documents such as bylaws, minutes to meetings, newsletters and important notices will be on the web soon as it is in the early development stage. Colleen prepared the master email address list to be transferred to the website so newsletters and important notices can be sent to everyone that provided an email address. Neighbors will be able to subscribe or unsubscribe at any time.

Action: Marilyn and Colleen will continue to be the administrators of the website. Contributors to the website was tabled for another meeting.

New Business/Other

Neighborhood Watch Signs: Colleen shared pricing and design from www.nnwi.org, the suggested site to order signs from if neighbors want them. The largest reflective sign is 18" x 24" and its price ranges from \$36.75 each for 1 to 3 signs and \$35.75 each for 4 to 14 signs. There is an anti-graffiti coating that can be added to each sign for an additional \$16, but Stephen pointed out that is nearly half the cost of the sign. Neighbors would be asked to fund the signs. There would be no installation fee, but we need direction where they can be installed before ordering.

Action: Colleen asked everyone to look for existing signs that might need replacing in their zone, also noting the size and style (photos may be helpful). Suggest new locations for signs. Colleen will ask RCONA and the Roseville Police Department Community Services if there is a standard sign being used by other neighborhood associations and location requirements. Colleen will also ask what financial help RCONA may provide.

Crestmont School Celebrating 50 Years: LaRon Golden mentioned Crestmont School is having its Carnival on Friday, October 25th, from 5:30 to 8:30 p.m. They are also celebrating 50 years!
