

South Cirby Neighborhood Association Meeting Minutes
May 13th, 2014
7:00 p.m.

Present: Stephen Costello, Colleen Cole, Marilyn Floyd, Officer Daniel Stokes, LaRon Golden and David Sears.

Meeting called to order by Stephen Costello. Stephen welcomed everyone and introduced the board.

Meeting minutes from 4/8/14 were approved.

Treasurer's Report: \$149.00. There were no transactions in the last month.

Reports/Old Business

Roseville Police Officer Neighborhood Report: No crime trends. On Ridgeview, a weed eater was stolen out of the back of a yard maintenance truck. Nothing flashing, but be vigilant and use smart practices with your property. A question was asked about what drugs were in the spotlight in our town. Heroin and Meth are what police are seeing in our city.

Neighborhood Watch: Colleen contacted the 21 South Cirby Neighborhood Watch (NW) Block Captains that initially expressed an interest. We now have 17 confirmed with two of those 17 being NW Block Co-Captains. Instructions were sent out to all Block Captains so they will be prepared to meet the end of May with Rob Baquera and get officially designated as a Neighborhood Watch area. The meeting date and place is yet to be determined as Rob Baquera is currently on vacation.

South Cirby Sound Wall and Hidden Hills Signs: Stephen, Marilyn and Colleen met onsite with Larry Hagen, Street Maintenance Supervisor, and Jerry Dankbar, City Street Maintenance Superintendent. The City gave us very specific guidance and recommendations for the sound wall and the neighborhood signs, however, the City Streets Department has no funds to help with this project. They offered to provide supervision and the approval of the project along with help in finding a Boy Scout if and when we are ready.

Colleen attended the "Coffee with City Council" on 5/12/14 with Council Member, Pauline Roccucci. She asked if City Council has ever considered a maintenance plan for unsightly sound walls that do not represent Roseville's image very well. Colleen complimented the City on upscale new projects, parks and new developments. But, Roseville residents do not want their neighborhoods to look like a place where graffiti artists come. Colleen told Pauline that the City Streets Department has around 45 miles of public sound walls that they cannot maintain (budget wise) other than using recycled paint to cover up graffiti within a 48 hour period. Pauline took Colleen's contact information and will get back with her.

Colleen cleaned off the wax like graffiti that was on the Hidden Hills metal sign located at Hidden Hills Drive and South Cirby Way. Old tape does not come off the signs. Colleen is checking into a product that may help remove the old tape without damaging the paint. Goo Gone only worked for removal of old putty. A gentle reminder to neighbors to not place any signs on the sound wall or neighborhood signs might be in order.

Hidden Hills Sign Improvement Options:

1. New signs from a sign shop - no estimate yet.
2. Take signs down, flip them over and have the City paint the backside and put on new block lettering keeping it simple at a cost from the City of about \$400.
3. Do away with the two signs altogether since other subdivisions do not have signs at their entrances. Repair of bolt holes would be necessary and may show after painting.
4. Clean signs as best as possible, remove them for painting the wall and then reinstall them.

Speakers for the June General Meeting:

Sean Bigley, Government Relations Analyst, City of Roseville has agreed to be our guest speaker on the drought. He will do an informal presentation and bring handouts.
