

South Cirby Neighborhood Association Meeting Minutes

Meeting called to order by Vice President, Marilyn Floyd, at 7:07 p.m. Marilyn welcomed everyone and introduced the board.

Meeting Minutes: There are no meeting minutes from the prior meeting on July 8, 2014 as there was no quorum.

Treasurer's Report: LaRon Golden submitted two treasurer's reports. The beginning balance on June 11, 2014 is \$206.96. A \$92.04 deposit from RCONA for reimbursement of our annual floating event (Election Celebration) brings our ending balance on July 8, 2014 to \$299.00. The beginning balance on July 9, 2014 is \$299.00. Expenses of \$75.36 for National Night Out bring the ending balance on August 12, 2014 to \$223.64. Hearing no objections, both treasurer's reports are placed on file.

Roseville Police Officer Neighborhood Report: Officer Quartarolo is new to beat 2's evening shift and she plans to come to our meetings in the future. People are still leaving their overhead garage doors open and she reminded us to keep them all the way down. Your door leading into the house from your garage should be kept locked as well as your exterior garage entry door. A question was asked about RVs and home invasions. There is a current problem with home invaders watching when your RV disappears and then invading your home.

National Night Out (NNO): Colleen Cole said about 50 neighbors attended our NNO ice cream social event on August 5, 2014 which was a lower turnout compared to last year. Our May printed newsletter initially announced the event and an e-newsletter was sent on July 28. The e-newsletter was sent out to 90 registered website users and only 48.3% opened or clicked on the newsletter. We all agreed that a printed newsletter needs to be delivered to the door closer to the event. Thank you to our wonderful neighbor volunteers as we could not do this event without you.

Movie in the Park (MITP): Marilyn reported the August 9, 2014 MITP showing of "The LEGO Movie" had a great turnout of people, possibly 350 to 400. Colleen said Crestmont Park is in great condition and she is going to send a thank you to Roseville Parks and Recreation because it is so obvious that Gary takes great pride in keeping the grounds in good shape and it is appreciated by all.

Website: Colleen said website improvements are needed. Suggestions or help is welcome.

New Business

No Soliciting Signs: Helen Dorr asked where to get the new cardstock "No Soliciting Signs" since she has neighbors requesting them and we ran out of them at our Neighborhood Watch meeting on July 23, 2014. Colleen will email the police department for this information. In the meantime, a sign can be printed from the City of Roseville Police Department website under Forms and Publications.
