South Cirby Neighborhood Association Meeting Minutes October 14, 2014 at 7:00 p.m. Crestmont Elementary School Multi-Purpose Room

Meeting called to order by Vice President Marilyn Floyd at 7:00 p.m.

Meeting Minutes: Hearing no objections, the vice president ordered the September 9, 2014 minutes approved as submitted and placed on file. In addition, the vice president ordered the June 10, 2014 minutes approved with two minor corrections and placed on file.

Treasurer's Report: LaRon Golden reported no activity from September 9, 2014 to October 14, 2014. The ending balance remains \$323.83. Hearing no objections, the vice president ordered the treasurer's report placed on file as submitted.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Dan Stokes, formerly in beat 2 and currently in beat 3, reported no new trends in crime. The police department recently arrested a couple of Sacramento Bee paper carriers stealing packages or other items from front porches in the early morning. Door kick burglaries continue. Compared to this time last year, violent crime in Roseville is down 20+% and property crime is down 8%. DUI collisions are up. More new officers have been hired.

Colleen reported RCONA Representatives received an email from Sergeant Josh Simon requesting that NAs let the officer present his/her report first in about a 15 minute window of time so that the officer can get back out patrolling the streets. SCNA has always allowed the officer to speak upon his/her arrival and is happy to comply with the 15 minute timeframe.

Marilyn reported a suspicious vehicle was called in to the police department today, but the vehicle left the neighborhood by the time the officer arrived. Later in the day, the vehicle was seen in another neighborhood in Roseville and the person was arrested. The Roseville Police Department has asked neighbors to call in suspicious vehicles.

Colleen reported solar solicitors were knocking on doors displaying "no soliciting" signs today. When asked to see their City of Roseville permit, a City of Rocklin permit was presented. It was suggested to the solicitors that they carry a City of Roseville permit and comply with Roseville's Municipal Code 10.36.030 when a sign in clear view prohibits soliciting.

LaRon reported residents would like help with speeders taking a shortcut through Crestmont Oak Drive to Sheridan Avenue while dropping off and picking up their children at Crestmont School. Officer Stokes put in a request for extra patrol in that area during the timeframe of 8:15 a.m. to 8:30 a.m. and again from 2:50 p.m. to 3:10 p.m.

Colleen inquired why the Botts' dots on Vista Creek Drive stop at the intersection of Summerhill Drive. Officer Stokes put in a request to continue the Botts' dots for the entirety of Vista Creek Drive to help separate the roadway lanes.

2015 Guest Speaker at NA Meetings: Colleen sent an email to Vice Mayor Carol Garcia asking if she would be a guest speaker at one of our monthly NA meetings in 2015. She responded she would be happy to speak at any of our meetings in 2015. Reviewing our calendar of events for the year along with our printed newsletter schedule, it was decided that the meeting dates of March 10 or April 14 would be

good options. Colleen will respond to Vice Mayor Carol Garcia to see which date works best for her. Stephen preferred the April 14 date because he thought more people would attend.

Printed Newsletter and Electronic Newsletter (EN) – Sponsors: During the past month, revisions were made to our SCNA policies and procedures sponsorship draft. RCONA is requesting that we share our adopted sponsorship policies and procedures with them because they don't have an adopted policy for sponsorships and they will be writing one in the future.

Marilyn motioned that we adopt the Policies and Procedures for Sponsorship and Event Booth based on our most recent changes and amendments may be made in the future if needed. LaRon seconded the motion and the vote was unanimous.

Colleen will furnish RCONA with these adopted policies and procedures.

Event Booth – Policies and Procedures: During the past month, revisions were made to the policies and procedures event booth draft and were adopted by the motion and vote above in red.
