Colleen will pick up a supply of NW stickers for block captains to give to their members wanting them. Marilyn said to watch for the new NW signs going up on Champion Oaks Drive and Hillmont Way.

**RCONA February 19, 2015 Meeting Update:** Stephen reported that RCONA is activating several new NAs this year. NA meeting turnout was also discussed with many neighborhoods reporting low turnout.

**Guest Speaker at April 14, 2015 Meeting:** Mayor Carol Garcia will be our guest speaker on April 14, 2015. Joe suggested we ask to use Crestmont School's microphone system. The SCNA newsletter will be ready for delivery the end of March. Stephen asked that we continue to think of topics for our Mayor and let him or Colleen know so that the Mayor can be notified ahead.

There is no limit to the number of signs put up, however, it would be best to put them in areas where traffic is coming and going. Prior approval from property owners would be required.
