

South Cirby Neighborhood Association Meeting Minutes  
February 9, 2016 at 7:00 p.m.  
Crestmont Elementary School Multi-Purpose Building

**Present:** Marilyn Floyd, Colleen Cole, LaRon Golden, Helen Dorr, Joe Dorr, Sergeant Jeff Kool, Officer Jordan Haley and Bill Floyd

Meeting called to order by Vice President Marilyn Floyd at 7:00 p.m. Marilyn introduced and welcomed everyone.

**Meeting Minutes:** Hearing no objections, the vice president ordered the January 12, 2016 minutes approved as submitted and placed on file.

**Treasurer's Report:** The report covers activity from January 1, 2016 to January 31, 2016. The beginning balance was \$958.11. With no activity during the month, the balance remains \$958.11. Hearing no objections, the vice president ordered the treasurer's report placed on file as submitted.

### **Reports/Old Business**

**Roseville Police Officer Neighborhood Report:** Sergeant Jeff Kool and Officer Jordan Haley gave us an update. Thefts continue in our neighborhood from package deliveries, mail, open garage doors and unlocked vehicles. We currently have extra patrol in our neighborhood and the Cirby Ranch neighborhood because of three recent door kick burglaries (Northbrook Drive, Carnation Court and Stonebridge Way). Robberies in Roseville were up significantly in 2015 mostly due to marijuana drug deals going bad. Heroin is abundant on the streets and abusers are stealing to get their next fix. All Roseville police officers will have body cameras in the next few months.

The Roseville PD is having a fundraiser for Officer Bobby Seich who is battling brain cancer for the second time in his life. Join the community at Strikes Unlimited in Rocklin on May 7, from 4:00 to 7:00 p.m. Fifteen percent of eligible purchases will benefit the Seich family. Sergeant Kool will send a flyer with more information so we can share with SCNA residents.

**Neighborhood Watch (NW):** Joe, Helen, Marilyn and Colleen attended the Annual Block Captain meeting on January 26. Captain Stefan Moore talked about Roseville PD's ASPIRE (Analytically Solving Problems in Roseville) newly adopted program similar to one the Citrus Heights PD uses. One of the many benefits of ASPIRE is that officers from different shifts and beats attend group meetings to share what is going on in their areas and shifts. This helps the Roseville PD to be proactive. Bill added that data helps determine the best areas for officers to patrol since they can't be everywhere.

We welcome a new NW group on Live Pine Court. Marilyn and Colleen attended their NW meeting at Cool River Pizza on February 1. It was a great meeting and good to meet more neighbors in our SCNA.

**SCNA Events for 2016:** Colleen checked with Sue Cook, RCONA, regarding use of bounce houses for National Night Out and her response was that they are pricey and vendors not always reliable. The vendor is required to have a liability policy with the City on file so that would need to be verified. The City requires special coverage so that brings up the price for a bounce house. Colleen expressed concern with bounce houses being germey. Colleen will follow up with Blue Oaks NA to see what their recommendation is on bounce houses. Stephen has a contact for a bounce house so we will get his report at another meeting.

**Project Ideas:** Colleen updated that the Meadow Oaks NA continues to work with RCONA and the City regarding a Friendly Visitor program proposal for elderly people living alone. Joe expressed concern for

volunteers going into homes and putting themselves at risk of being accused of something. While we don't know the details of the program yet, Colleen felt our participation could be limited to a daily check-in phone call at an agreed upon time or a knock at the door without entering. Colleen will learn more at future RCONA meetings and will ask who would provide liability coverage for volunteers.

LaRon mentioned that the Crestmont PTC walking path project fell through.

### **New Business**

**Newsletter Topics:** The following topics were brought up for future newsletters: fundraiser for Bobby Seich, animal etiquette, proper flag disposal offer from Blanch and Gary Beckes, Box Tops for Education, grocery store programs that benefit schools, upcoming event listing, survey if there are any ideas for neighborhood improvements (for example, Crestmont Park playground improvements besides the shade suggestion we learned from moms at the park).

**MITP Movie Selection:** Keeping movie running times in mind, we are recommending the following movies from RCONA's list for this summer's MITP events: *Field of Dreams*, *Aladdin*, *Hotel Transylvania 2*, *Earth to Echo*, *Disney's Bedtime Stories* and *Goonies*. Colleen said she feels Crestmont Park has a very good chance of having a MITP this year.
