South Cirby Neighborhood Association Meeting Minutes March 8, 2016 at 7:00 p.m. Crestmont Elementary School Multi-Purpose Building

Meeting called to order by President Stephen Costello at 7:00 p.m. Stephen introduced and welcomed everyone.

Meeting Minutes: Hearing no objections, the president ordered the February 9, 2016 minutes approved as submitted and placed on file.

Treasurer's Report: The report covers activity from February 1, 2016 to February 29, 2016. The beginning balance was \$958.11. A deposit of \$15 for the www.handipockets.com website sponsorship brings the ending balance to \$973.11. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Jordan Haley gave us an update. Fortunately our neighborhood has been relatively quiet this past month possibly because of the increased evening patrols in our area.

The State of California closed down many full-time psychiatric care facilities and allows level 4 psychiatric care homes to operate in residential neighborhoods with cities having no input. Level 4 is the highest level allowed in California residential neighborhoods. SCNA currently has two of these women's facilities very close to each other. Police and Fire are responding to these care homes almost every day and sometimes several times a day. Nothing can be done unless the State changes requirements for these homes. Responding officers are documenting every contact. Assistant Chief of Police Maccoun is keeping track of the number of police reports written and the City might start billing the State program that mandates these facilities be here. The City is working on this problem because it is a resource strain on the PD and stress for neighborhoods. Stephen asked if the State limits the number of homes and distance between them in neighborhoods. Stephen also asked if the State can still allow this type of business if our CC&Rs don't allow it. Officer Haley suggested talking to City Council.

Neighborhood Watch (NW): The next NW informational meeting is March 22, 2016, from 5:30 – 6:30 p.m. at the Roseville PD (Mark White Room). Colleen will contact people that previously expressed an interest in becoming block captains so they can attend this informational meeting.

Cesar mentioned he recently had Roseville Electric change his meter to a wireless version for free because he wanted to keep his gates locked for security reasons. If your meter is behind a locked gate, you could be fined \$50 if Roseville Electric couldn't access it to read it. Only people with meters behind gates would have the wireless option. Colleen is going to contact Roseville Electric to learn more.

SCNA Events for 2016: The **April 12, 2016 SCNA General Meeting** will feature guest speakers Paul Camilleri, Roseville Code Enforcement, and John Bennett, Roseville Animal Control. Colleen suggested we have questions or concerns ready to help get the question and answer period started after the presentations.

Marilyn registered nationally for our upcoming **August 2, 2016 National Night Out** and she will also submit paperwork to RCONA for our event when they request it.

MITP Movie Selection: Colleen announced Crestmont Park was chosen to have a MITP this summer. The schedule and movie list is being finalized so next month we will have more details.

New Business

Closed Group Facebook Pages: Cesar talked about establishing SCNA closed group Facebook pages. SCNA already has a Facebook page, but we're interested to improve it. Cesar recommends having two Facebook pages; one dedicated for neighborhood news and another dedicated to "for sale or free" items. Residents would ask to join over Facebook and after verifying that they live in our SCNA, they would be accepted. Marilyn asked Cesar if he would set up these group pages and be a moderator. Cesar agreed and suggested that other board members be moderators as well. He offered to create drafts for board approval before incorporating people into the groups.

Marilyn motioned that Cesar create and moderate the SCNA closed group news and "for sale" Facebook pages along with some board members. The motion was seconded by Helen. Voice vote passed unanimously.
