

South Cirby Neighborhood Association Meeting Minutes
August 9, 2016 at 7:00 p.m.
Crestmont Park

Meeting called to order by President Marilyn Floyd at 7:01 p.m. Marilyn introduced the board and welcomed everyone.

Meeting Minutes: Hearing no objections, the president ordered the July 12, 2016 minutes approved as submitted and placed on file.

Treasurer's Report: The report states no activity from July 1, 2016 to July 31, 2016. The ending balance remains \$1003.11. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Mike Sidebottom gave an update for our area, provided tips and answered questions. Make houses and vehicles a hard target to get into. Keep cars in your garage. Alarms and animals are helpful. Keeping lawns mowed gives the impression you are home. Most solved cases come from people calling in and reporting suspicious activity. Beat two is a very large area so it is imperative that people report suspicious activity because officers cannot be everywhere at once. Colleen mentioned people are currently posting on Nextdoor about a cat that was shot and killed by a BB gun in the Maidu area. Some posts said the Roseville PD will chime in soon. City of Roseville employees cannot see or respond to Nextdoor posts. The deceased cat's owner should call Roseville Animal Control to report the incident. Calling 911 from a cell phone in Roseville's city limits will now route directly to Roseville's dispatch. When you are outside Roseville's city limits, calling 911 on a cell phone will route to CHP. We will update our next newsletter with this cell phone 911 information.

National Night Out: We partnered our event with Cirby Ranch Neighborhood Association (CRNA) making it easier for City departments to visit all NNO events. We had a free BBQ of hot dogs, chips, water cookies, frozen Italian Ice and Push Ups. Colleen reported an attendance estimate of over 120 people. New activities were a Placer County Food Bank drive, raffle prize drawings throughout the event, face painting and a self-serve photo booth. Our face painting volunteers estimated they painted about 20 children. LaRon suggested music for next year. We will continue to look for talented individuals in our neighborhood for music, DJ, face painters, balloon artists, magicians and clowns. Reid's connection with Raley's Corporate (Kristina Garris) provided a generous food and water donation. Placer County Mosquito & Vector Control provided individual mosquito wipes. Raffle prizes were donated by Target, Bob's Carwash & Detail, Moe's Southwest Grill (also chips and salsa), Mr. Pickle's Sandwich Shop, Keller's Tae Kwon Do, Starbucks and Subway. McDonald's provided ice. Leftover food in unopened packages was donated to non-profit organizations (Placer County Food Bank and St. Vincent de Paul). Cash donations of \$60 were split evenly between the two NAs.

2nd Annual Garage Sale: LaRon has received four registrations for our October 1st neighborhood garage sale. Colleen will update the website home page with the garage sale information now that the National Night Out information can be removed. She will also send an E-blast reminder. Marilyn will post on Nextdoor and Facebook. A half page reminder flyer will be delivered in early September. Marilyn offered her home again as the location for participants to pick up their helium filled balloons to identify their home as having a sale. Colleen asked everyone to seek volunteers for map passing at busy intersections for the early hours of the garage sale.

New Business

RCONA Template for NA Bylaws: Colleen provided each board member with a copy of RCONA's recently approved template for NA bylaws which is more closely aligned with the RCONA Bylaws and RCONA Code of Ethics. Board members will compare our current SCNA Bylaws with the RCONA template for NA bylaws and discuss through email and future monthly meetings. After review process is complete, we could vote on revised SCNA Bylaws at a general meeting.
