

South Cirby Neighborhood Association Meeting Minutes

Meeting called to order by President Marilyn Floyd at 7:00 p.m. Marilyn welcomed everyone and introduced the board.

**Meeting Minutes:** Hearing no objections, the president ordered the April 11, 2017 minutes approved as submitted and placed on file.

**Treasurer's Report:** The report covers activity from April 1, 2017 to April 30, 2017. A beginning balance of \$1,349.11 with one expenditure of \$55.00 for Adobe Acrobat Pro software purchased from RCONA brings the ending balance to \$1294.11. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

### **Reports/Old Business**

**Roseville Police Officer Neighborhood Report:** Officer Gillespie reported that the shooting on Schooner Avenue (part of CRNA) was a targeted house and not a random drive-by shooting. No one was injured. This is a good time of year to remind people that Roseville PD volunteers offer vacation house checks. The exterior of your home will be checked as time permits, making sure doors and gates are secure and any unwanted papers or advertisements are removed from the front porch. Submit your request at least a week before your departure date. Officer Gillespie recommends having someone mow your lawn if you will be gone for an extended time. A question was raised concerning homeless camps and what is being done to clean them up. Updated legislation protects the rights of all persons, regardless of their housing status. Persons experiencing homelessness are permitted to use public space at any time that the public space is open to the public without discrimination based upon their housing status, and without being subject to criminal, civil, or administrative penalties. A city crew goes to encampments and posts 48 hour notices for people to pick up trash and belongings. The crew returns 48 hours later and removes any remaining items.

**Roseville Firefighters:** Not able to attend.

**Annual Meeting and General Election:** The required minimum of volunteers (5) submitted their nomination requests and short biographies by the May 8, 2017 deadline. The General Election is Tuesday, June 13, 2017, at 7:00 p.m. in the Crestmont Elementary Multi-Purpose Building. Zen Landis from Green Acres Nursery & Supply will be our guest speaker.

**3<sup>rd</sup> Annual Garage Sale:** Our neighborhood garage sale is October 7, 2017 from 8:00 a.m. to 1:00 p.m. Colleen is waiting to hear if Stephen Costello would like to sponsor the event again this year. Marilyn and Colleen will review the timeline and meet with the sponsor to organize the event and streamline duties. We welcome volunteers for committee work and also the day of the event. Obtaining raffle prizes requires solicitation. If you know of a small business in our neighborhood or other business nearby that might be interested in offering a small donation, please contact them. Last year, Colleen shared our May newsletter with businesses which created interest. It is also good to mention that we are a 501(c)(3) public benefit community organization.

## **New Business**

**National Night Out:** August 1, 2017 is our National Night Out (NNO) event. Marilyn registered with both the National Association of Town Watch and City of Roseville for our neighborhood event to be held at Crestmont Park Pavilion. LaRon mentioned that Curves would like to set up a table at our NNO. Roseville Police and Fire will be there along with other Roseville and Placer County representatives.

**City of Roseville Community Priorities Advisory Committee (CPAC) Recruitment:** “Engage Roseville” is a community effort to involve residents, businesses, and others who have a stake in Roseville’s quality of life, in prioritizing city services and developing options to align service levels with revenues. More information about the CPAC responsibilities and application is available on the city’s website. The application deadline is May 19, 2017.

Sue and Joe are new to our neighborhood and volunteer with the Roseville PD. They will let us know if a cyber safety program for children becomes available and will inquire with Rob Baquera regarding speaking at a monthly meeting with the cyber safety topic geared towards children and their parents. Sue and Joe also volunteer for the annual **Placer Veterans Stand Down** which is May 23, 24 and 25, 2017 at the Placer County Fairgrounds.
