Treasurer's Report: The report covers activity from July 1, 2017 to July 31, 2017. A beginning balance of \$1,294.11 plus deposits of \$10 for a garage sale registration and \$20 for a garage sale donation bring the ending balance to \$1,324.11. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

National Night Out: Even though it was a hot evening, over 90 neighbors and 25 City employees and business vendors attended our NNO free BBQ of hot dogs, chips, water and desserts. Activities were visits from the police, fire and probation departments, raffle prize drawings, face painting, treasure chest toys, games and a self-serve photo booth. Five neighborhood businesses set up vendor tables: Roxanne O'Moore – Pampered Chef, Patty Hidalgo – Curves, Stephen Costello – Century 21, Target and Kristi Kinzel – Tupperware. Raffle prizes were donated by Curves (1801 Cirby Way), Romano's Macaroni Grill (2010 Douglas Boulevard) and Peet's Coffee & Tea (1200 Cirby Way). Food, desserts, water and ice donations were from Target (1925 Douglas Boulevard) McDonald's (1190 Cirby Way), Bel Air (1039 Sunrise Avenue) and 7-Eleven (2000 South Cirby Way). Target employees volunteered to face paint and serve their mini ice cream sandwiches and popsicles. All volunteers and donations are sincerely appreciated. Reid suggested a future improvement. When we know how many vendors will participate, we will determine a plan so they are better positioned. Also, Colleen suggested sending an e-blast regarding our NNO event thanking our vendors and donors rather than waiting for our December newsletter. The e-blast will allow us to provide additional promotion for these businesses.

3rd Annual Garage Sale: Colleen has received three registrations for our October 7 neighborhood garage sale. The information is already posted on our website's home page, but Colleen will remove the NNO information so the garage sale information is immediately visible. Colleen will contact a couple of businesses that seemed interested in providing raffle prizes for the garage sale. At this time, we have one possible raffle prize. Cool River Pizza (1805 Cirby Way, Ste. 3) will again generously provide a free medium pizza coupon for each garage sale registrant. Registration deadline is September 23 for getting your address on the neighborhood map to be passed out at four major intersections the morning of the sale. Nick will prepare the map on September 25. Our garage sale sponsor, Stephen Costello – Century 21, will deliver helpful packets to all registrants at least one week prior to the garage sale. On October 7, we need volunteers to help fill helium balloons and pass maps. Marilyn volunteered her home for filling

helium balloons starting at 7:00 a.m. Map passing would likely be one hour shifts between the hours of 8:00 a.m. – 10:00 a.m. Colleen will check with Denal Green from Oakmont High School's Interact Club to see if she would have any volunteers interested in community service hours. Reid will check his boys' soccer schedule to see if map passing would work for them. Stephen will have boxes put on four signs with balloons so when map passers have finished their duty, people can drive up to get a map. Marilyn is also working on extra signage.
