Meeting called to order by President Marilyn Floyd at 7:02 p.m. Marilyn welcomed everyone and introduced the board. A quorum was not present and no votes were taken on any matters.

Meeting Minutes: Hearing no objections, the president ordered the September 12, 2017 minutes approved as submitted and placed on file.

Treasurer's Report: The report covers activity from September 1, 2017 to September 30, 2017. A beginning balance of \$1,399.11 plus a deposit of \$100.00 for RCONA's NNO reimbursement along with a Crestmont Elementary School (EXPO markers) expenditure of \$98.08 and NNO expenditures of \$41.74 bring the ending balance to \$1,359.29. The president ordered the treasurer's report placed on file as submitted.

Roseville Police Officer Neighborhood Report: Officer Haley reported while burglaries are down, scams are on the rise. Large retailers benefit from using loss prevention trained employees. Cashiers could be suspicious if a customer attempts to pay with multiple gift cards that could have been obtained from scams. Calls for service regarding transients are very high now.

Roseville Firefighters: No firefighters able to attend.

3rd Annual Garage Sale – Review of Event: In 2015 we had 43 registrations, 2016 had 37 registrations and 2017 had 28 registrations. The number of tagalongs this year was discouraging. This event is our only fundraiser throughout the year and provides funds for our free National Night Out event. We were fortunate to have an Oakmont student passing maps this year and he will receive a certificate of volunteer hours. A shopper mentioned it was difficult to find Edgewater Court. Our Google map doesn't show any cul-de-sac names on it. Colleen suggested in the future we provide extra balloons and/or a garage sale sign at the entrance of a participating cul-de-sac. Also, there may be other mapping options we can investigate. Signs and map holders at four major entrances to our neighborhood were excellent. Social media advertising was effective. Congratulations to our participant raffle prize winners, Richard and Loretta Retherford and Benito and Leah Garcia.

"Boo" Event: Eight "Boo" baskets will be assembled with delivery beginning October 13th throughout the SCNA. Our committee maintains a list of "Boo" past recipients so that we can spread the good cheer to more people over the years.
