Meeting called to order by President Marilyn Floyd at 7:03 p.m. Marilyn welcomed everyone and introduced the board. A quorum was not present and no votes were taken on any matters.

Meeting Minutes: Hearing no objections, the president ordered the October 10, 2017 minutes approved as submitted and placed on file.

Treasurer's Report: The report covers activity from October 1, 2017 to October 31, 2017. Roseville Police Officer Neighborhood Report: Officer Gruchow reported that new California laws will help with transients better. Between the hours of 6:00 a.m. to 9:00 p.m., transients can be cited for camping on City owned property (parks, open space, City Hall and creek beds). Police may contact transients any time in a City park, but after dark, the citing would be for being in the park after dark. Transients have the right to sleep somewhere. City now has two transient officers which should be helpful. Officer Gruchow requested again that residents with surveillance cameras consider registering them with the Roseville PD. Information is available on their website and this has really helped Roseville PD.

Roseville Firefighters: No firefighters able to attend.

"Boo" Event: "Boo" event was successful. LaRon, Colleen and Nick were "Boo'd" and several other homes in the neighborhood had the SCNA "Boo" sign up so it seems like a friendly event to continue at a low cost. It has been noted that as homes are sold, young families are moving back to our neighborhoods and would likely participate.
