Meeting called to order by President Marilyn Floyd at 7:01 p.m. Marilyn welcomed everyone and introduced the board. A quorum was not present and no votes were taken on any matters.

Meeting Minutes: Hearing no objections, the president ordered the November 14, 2017 minutes approved with one correction and placed on file.

Treasurer's Report: Two reports cover activity from November 1, 2017 to November 30, 2017 and December 1, 2017 to December 31, 2017. We do not hold a monthly meeting in December. Neither report had activity so the beginning balance of \$1,660.70 in November is the ending balance in December. The president ordered the treasurer's report placed on file as submitted.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Williams reported an increase in package thefts primarily in West Roseville over the holidays, but no neighborhood is immune. Good video surveillance from the Ring is providing the investigative department clear photos that may help identify porch pirates.

The Roseville PD is having a Semi-Annual Neighborhood Watch Block Captain meeting and Colleen reported that people want to learn more about homelessness and what the City is doing about it. LaRon mentioned that people were sleeping at Crestmont Park in the tunnel slides a year ago so we are requesting the PD to keep watch for that. So far this winter, transients haven't been reported in our neighborhood. In East Roseville, 50% of calls for service are transient related issues mostly along Douglas Boulevard with its commercial complexes. Camps are common at Saugstad Park, Royer Park and also a few along Sunrise Avenue and Rocky Ridge Drive. Patrol is enforcing camping ordinances when appropriate and dealing with quality of life and crime related issues that arise from the transient population. The Social Services' unit is working with the transient population to find placement for those who qualify and putting them in touch with resources. Officers see the same transients every day and the majority are voluntary homeless and longtime homeless. Ages range from early twenties to mid-fifties, but the majority are aged 35 to 55 and have ties to Roseville.

In the last four to five years, an opioid drug epidemic has developed in Roseville and it is not uncommon to see people shooting up even at shopping centers. Please call the PD when you see this. Officers carry overdose kits in their patrol cars now.

Roseville Firefighters: No firefighters able to attend.
