Meeting called to order by President Marilyn Floyd at 7:03 p.m. Marilyn welcomed everyone and introduced the board.

Meeting Minutes: Hearing no objections, the president ordered the June 12, 2018 minutes approved as submitted (with possible clarifications from Einar Maisch) and placed on file.

Treasurer's Report: The report states no activity from June 1, 2018 to June 30, 2018. The ending balance remains \$1,660.20. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Ryan Bal inquired if suspicious activity at Crestmont Park has quieted down and Marilyn feels that it has. He reported no new trends in crime. Keep your garage doors down and vehicles locked with items out of site. Bank robberies are up in Roseville with one as recent as today at Chase Bank on Douglas Boulevard resulting in a crash and arrest. Calls for service regarding illegal fireworks were about the same as previous years. However, there were more loud aerial fireworks throughout Roseville than in the past. Colleen wondered if it could have something to do with Roseville not having a fireworks show this year due to budget cuts. Marilyn noticed a homeowner posted a Ring video of a suspicious person checking door knobs to see if houses are locked. It is best to call the PD when you notice something like this on your Ring surveillance system.

Roseville Firefighters: No firefighters able to attend.

Movie in the Park at Maidu Volunteer Reminder – July 14: We will have 3 volunteers (Marilyn, Colleen and Bill Floyd). The City doesn't want volunteer help with set up, tear down or clean up as in years past. The movie is "Wonder".

National Night Out (NNO): Our NNO is on Tuesday, August 7, from 6:00 p.m. to 8:00 p.m. Board members will begin set up at 5:00 p.m. Marilyn and Colleen are seeking donations for the event. We have received positive responses from last year's donors, but actual items need to be finalized. Target will provide some food items and employee volunteers. At this time, two businesses have board approval to set up their own vendor tables (Patty Hidalgo – Curves and Steven Costello – Century 21). Marilyn and Colleen will shop for toys for the children's treasure chest. Colleen requested the Corn Hole game like we did a few years ago so Marilyn will ask Bill and Reid. Nick said that making announcements was difficult without a microphone so Colleen will check into availability of a microphone. Marilyn will provide green slips for people to write their name on for the raffle. LaRon will work the registration table along with another volunteer to be determined. Expected expenses are unknown at this time.

LaRon motioned to allow spending up to \$50 (if necessary) over the \$100 that will be reimbursed by RCONA. The motion was seconded and voice vote passed unanimously.

Fourth Annual Garage Sale – October 6: Marilyn reported our registrations and raffle prize donations remain the same as last month. This is normal for this time of year. Our upcoming newsletter and National Night Out event will be good reminders for people. Deadline to register is September 22.

New Business

NA New Neighbor Welcome Packet: Marilyn reported that Robert Sanchez (Pleasant Grove NA President and RCONA board member) has organized a NA New Neighbor Welcome Packet with City items to share with new residents. The items include a reusable shopping bag from Roseville Electric and various informational publications or cards. Other items could be added to the bag. Nick mentioned when they moved into their first home eight years ago in the Cresthaven NA area, they received a welcome bag that included similar items, restaurant offers and a gift certificate for a free doormat from Walmart with no dollar limit. Nick offered to check with Walmart to see if this is something they would still consider doing. Marilyn will contact Robert to get us on the list for the next distribution of these packets.

General Meeting Topic – Neighborhood Watch Annual Block Captains Meeting: Colleen learned that Cirby Ranch NA has a general meeting topic on NW annually.
