Meeting called to order by President Marilyn Floyd at 7:03 p.m. Marilyn welcomed and introduced everyone.

Meeting Minutes: Hearing no objections, the president ordered the July 10, 2018 minutes approved as submitted and placed on file.

Treasurer's Report: The report covers activity from July 1, 2018 to July 31, 2018. A beginning balance of \$1,660.20 plus deposits of \$30 for three garage sale registrations along with a withdrawal of \$22.84 for National Night Out expenditures bring the ending balance to \$1,667.36. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

Roseville Police Officer Neighborhood Report: No officers able to attend.

Roseville Firefighters: No firefighters able to attend.

National Night Out (NNO) – Review of Event: Neighbors enjoyed socializing with Roseville Police and Fire, Placer County Chaplains and our Assistant City Manager at our free NNO BBQ. Activities included raffle prize drawings, a self-serve photo booth, treasure chest toys and games. Corn Hole was a big hit with all ages and Police and Fire will likely have a rematch next year. Neighborhood attendance was down from prior years, likely due to heat and air quality. However, City and County attendance was awesome. We were pleased to have fellow neighbor, DJ RayRay, provide music for the neighborhood (something we've been wanting for years). We also welcomed Patty Hidalgo from Curves for the second year in a row. Leftover food in unopened packages was donated to non-profit organizations (Placer County Food Bank and St. Vincent de Paul). Notes were placed in the secretary's binder to help plan for next year's event.

We will be short map passers so Colleen will request Oakmont High School volunteers for the first two hours of the sale. The October 6 date does not conflict with Oakmont's Homecoming. LaRon suggested contacting Crestmont Elementary School to see if we can put an announcement about our neighborhood garage sale in an upcoming newsletter. Other advertisements will be website (already on home page), Craigslist, Nextdoor and Facebook.

NA New Neighbor Welcome Packet: Marilyn received eight packets from RCONA with City information to give to new neighbors. She will check with Stephen Costello about homes recently sold in our NA. Marilyn said one NA included inexpensive Dollar Store items such as pot holders, oven mitts or kitchen towels to help fill the bags and spent around \$25.

Budget/Goals - Crestmont Elementary School Donation for Use of Meeting Room: Last year, SCNA donated EXPO markers to Crestmont Elementary School teachers up to a \$100 total value. Nick offered to contact Principal Farmer again this year to see what items are on the school's wish list and he will report back with ideas for us to consider.

"Boo" Event: For the past three years, Our SCNA "Boo" event involved delivering "Boo" baskets to eight different young families throughout the SCNA. Colleen reported we already have some items on hand for eight baskets. Sue Van Zant and Wendi Fuerstenberger have some children in mind and will deliver to them and provide the addresses to Colleen for recordkeeping. Last year's budget for this event was up to \$50 and \$28.59 was spent.

Colleen motioned that we deliver eight "Boo" baskets to different families throughout SCNA with a budget of \$25 since we already have some supplies. The motion was seconded and voice vote passed unanimously.
