## South Cirby Neighborhood Association Meeting Minutes Member of Roseville Coalition of Neighborhood Associations January 8, 2019 at 7:00 p.m. Crestmont Multi-Purpose Building

Present: Marilyn Floyd, Colleen Cole, LaRon Golden, Reid Allen and Officer Ann Marie Howland

Meeting called to order by President Marilyn Floyd at 7:00 p.m. Marilyn welcomed and introduced everyone.

**Meeting Minutes:** Hearing no objections, the president ordered the November 13, 2018 minutes approved as submitted and placed on file.

**Treasurer's Report:** Nick was called out of town for work and not able to attend this meeting so the November and December reports will be presented at our February 12, 2019 meeting.

## **Reports/Old Business**

Roseville Police Officer Neighborhood Report: Officer Ann Marie Howland presented a crime update and trends handout as of January 2019. This handout and future handouts will be filed in the secretary's binder. The top five crimes in Beat 2 are: burglary/theft from vehicle 44%, petty theft 21%, shoplifting 17%, vehicle theft 10% and assault 8%. Beat 2's burglary/theft from vehicles percentage is higher than the citywide average of 39%. January is statistically a high month for vehicle burglaries and fitness center parking lots are a top choice for burglars. January is also statistically a high month for residential burglaries mostly in the garage. Keep garage doors closed and locked. The PD is looking for a Chevrolet HHR black vehicle, license plate HBU065 or similar number, with a male black driver with dreadlocks and sometimes a female passenger. He has been seen breaking windows of vehicles with his elbow at both the Galleria and the Fountains shopping centers.

**Roseville Firefighters:** No firefighters able to attend.

General Meeting Topics/Speakers for Future Meetings (April and June): April 9, 2019 was the majority email vote of our board for our spring meeting with a UC Master Gardener speaker and "Raised Bed Gardening" topic. It is possible that the speaker may end up being a City of Roseville employee if a UC Master Gardener is unable to do it, but they would arrange it with the City of Roseville. The City of Roseville puts on these types of workshops for a fee, but our speaker would be free. Colleen is waiting to hear back from the UC Master Gardener as to who our speaker will be.

## **Budget/Goals:**

NNO Food Truck – Nick provided an update by email. He spoke with the most popular food truck vendor (taco) from the Crestmont School activities and they only do "free" events for schools and not all non-profits. For two hours, they have a \$900 minimum so if they sell less than that, we would be on the hook for the rest. Colleen spoke with Robert Sanchez from PGNA and their food truck vendor expected a minimum of 300 people or \$300. After their NNO, the vendor told Robert that he would not come again because he didn't make enough money. Robert feels that combined NA events with over 500 people might work with food truck vendors. Sue Cook emailed a response to Colleen about FFNA/WPNA's combined NNO event. Their food truck vendors didn't show up (except the shaved ice vendor), so they had no food to offer people. They provided root beer floats and water for free, but people went home early likely because they were expecting food. Sue also mentioned that the food truck vendors for RCONA's Movie in the Park have been very flaky too (different vendors than the ones she contacted for NNO). She suggests planning our NNO event for what we can count on. If we have food vendors, we need to get the RCONA releases signed now. Colleen stopped at Jamba Juice on Sierra College Boulevard and spoke with the store lead. He said they go to events and he encouraged us to contact the General Manager for more information. Colleen will email the General Manager to explain what

SCNA does and also explain NNO if she is not familiar with it. The same SCNA documents used when soliciting will be emailed to her along with the link to our December newsletter showing how we thank businesses for their support. After discussion, everyone agreed that food truck research can cease, but Colleen will do further research with Jamba Juice and present pricing at a meeting in the future.

Garage Sale Mapping Options, Spring or Fall – Colleen did not have an update yet on better mapping options. Colleen spoke with Jim Kidd and Maidu has not voted on their annual garage sale April date yet. He cannot speak for others on the Maidu Board, however, he personally doesn't mind if we have ours on the same date. He did question, however, how many garage sales can people attend in one day since Maidu NA has anywhere from 80 to 100 each year. Spring versus fall discussion continued.

LaRon motioned to schedule our next garage sale in the spring of 2020 (date to be determined) and skip this year. Motion was seconded and passed unanimously.

Christmas Contest (Holiday Participation) – Colleen reported only two board members responded by email saying if interest is there, a committee should be formed and planned well ahead of the holidays. LaRon suggested the event could be named Holiday Participation rather than Christmas Contest. Colleen has samples of certificates that other NAs have provided for their winners. After discussion, everyone agreed that a committee should be formed and start planning no later than October.

**New Neighbor Packets Budget** – Colleen reported a \$5 budget was approved by email to include a small gift in each new neighbor packet.

**Crestmont Donation for Night Custodian** – Colleen reported a \$20 gift card to be presented to night custodian, Richard Steed, at the end of this school year was approved by email. However, not everyone voted on the gift card business so discussion continued.

LaRon motioned to purchase a \$20 gift card from Bass Pro Shop. The motion was seconded and passed unanimously.

Recruiting Board Members – Upcoming RCONA Spring BBQ and Team Building Summit – Colleen is on a committee to help plan this new RCONA event. It must first be approved by RCONA's E-Board and then it will be presented at the upcoming RCONA meeting on January 17, 2019. Colleen would like the main topic at this event to be "Recruiting and Retaining Board Members". Reid agreed board development is huge and he has heard speakers on this topic. His suggestion is for current board members to come up with three things that have inspired them to join the board and go out and talk with people. Ask people if these three things are of interest to them and, if so, let them know we'd love to hear their voice.

**Meeting Date:** Jim Kidd got it down to three NAs now instead of five NAs on the same meeting day and time (RHNA, FFNA/WPNA and SCNA). Community service officers will now attend NA meetings if police officers aren't available. We agreed we would like to continue our current meeting day and time and we will see how this latest change works out.
