

South Cirby Neighborhood Association Meeting Minutes

Meeting called to order by President Marilyn Floyd at 7:01 p.m. Marilyn welcomed and introduced everyone.

Meeting Minutes: Hearing no objections, the president ordered the January 8, 2019 minutes approved as submitted and placed on file.

Treasurer's Report: The reports cover activity from November 1, 2018 to January 31, 2019. A November beginning balance of \$2,277.03 along with withdrawals for \$13.93 (NNO), \$10.23 (Boo basket candy) and \$148.12 (Expo markers for Crestmont Elementary School) bring the ending balance to \$2,104.75. The December and January reports have no activity so the ending balance remains \$2,104.75. Hearing no objections, the president ordered the treasurer's report placed on file as submitted.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Lopez presented crime updates. Beat 2's top two crimes are burglary/theft from vehicle and shoplifting due to all the businesses in the area. Beat 2's assaults, vehicle theft and vandalism are at 12% each. February is a lower month for crimes. Top Citywide crimes are burglary/theft from vehicle and theft in general. Identity theft increases as tax season approaches.

Roseville Firefighters: No firefighters able to attend.

General Meeting Topics/Speakers for Future Meetings (April and June): The UC Master Gardeners of Placer County confirmed the speaker for our April 9 meeting will be Kelly Warman presenting on "Raised Bed Gardening". Colleen will arrange for the night custodian to have the screen pulled down for the power point presentation. Colleen suggested we invite other NAs to this meeting to increase attendance and provide a service to others. Marilyn will invite NAs at the upcoming RCONA meeting. Wendi offered to invite people from the Roseville Better Gardens Club.

When our Mayor is appointed by City Council, Colleen will request the Mayor to provide a City update at our June 11 election meeting.

Budget/Goals:

NNO Food Vendors – Colleen contacted Jim Kidd, RCONA, for a copy of the "Hold Harmless Agreement" that Sue Cook mentioned we would need to have signed if having vendors at our event. This document may turn vendors off. Colleen emailed Jamba Juice's General Manager to see if they would like to either attend our event as a vendor or provide smoothies for our event or at a discounted rate. Colleen missed a Jamba Juice phone call today so an update on their interest in our event will be provided next month.

Garage Sale Mapping Options – Colleen asked a second neighbor for their help in this area and he was willing to look for a better map for us to use. Colleen shared the garage sale map that Marilyn had gotten from the Cirby Ranch NA and we felt it possibly came from some real estate software so Colleen will also reach out to Stephen Costello. Discussion on possible garage sale dates was tabled to another meeting.

Holiday Participation – No update on this new possible activity, but there is plenty of time to plan so discussion was tabled for another meeting.

Recruiting Board Members – Upcoming RCONA Spring BBQ and Team Building Summit – The RCONA Spring BBQ and Team Building Summit has been postponed due to a lack of committee members able to plan the new RCONA event for this spring. Hopefully it will be planned for the spring of 2020.

New Business

Neighborhood Watch Block Captain Meeting Update: Marilyn reported that Sergeant Darren Kato (Crime Suppression Unit) works with five categories: narcotics, thefts, gangs, massage parlors and prostitution. There are 131 massage parlors in Roseville and only 10% are legal. If there are curtains in the windows, don't go there. Heroin is the big drug now and it smells like vinegar. Lieutenant Brian Lewis also spoke and provided statistics and suggestions to deter crime. One suggestion was to put a "day sleeper" sign on your door. Do not leave valuables inside your car. TAKE your valuables with you. LOCK your car. HIDE the things you cannot take BEFORE you arrive at your destination. When you see something on public property that needs to be cleaned up, report the public nuisance violation by filling out the Code Enforcement Complaint Form available on the City's website. August 6 is NNO and Marilyn will register SCNA for our event.
