Meeting called to order by Vice President Reid Allen at 7:03 p.m. Reid welcomed and introduced everyone.

Meeting Minutes: Hearing no objections, the vice president ordered the August 13, 2019 minutes approved as submitted and placed on file.

Treasurer's Report: The report covers activity from August 1, 2019 to August 31, 2019. A beginning balance of \$1,980.56 plus deposits of \$35 for National Night Out (NNO) donations and \$319 for fireworks booth fundraiser along with two withdrawals totaling \$170.41 for NNO expenditures bring the ending balance to \$2,164.15.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Bryan Kruse reported beat 2 residential burglaries are down 3% from this time last year, but commercial burglaries are up 10%. Bryan asked if we had any questions and here are his replies. Price of methamphetamine has plummeted because users switched over to heroin when its price was lower. Use of these drugs goes back and forth based on price. There is a bad batch of methamphetamine in Roseville and the source is not known. Smash and grabs most commonly occur at commercial businesses such as Golfland Sunsplash, Galleria, Fountains and fitness centers and they were hit hard this summer. The police car decoy parked at various commercial businesses likely doesn't have an effect on career criminals, but it may have an effect on high schoolers or people down on their luck. School resource officers and a K-9 officer still use the Crown Victoria cars. The boundaries for the new beat 7 are still being determined. It is possible that beat 2 would be made smaller. There is a new problem oriented policing (POP) officer assigned to the homeless population and now there will be 24/7 coverage for them. The calls for service at the Hidden Hills care home have gone down in the last year.

Roseville Firefighters: No firefighters able to attend.

National Night Out: Colleen reported that all donor thank you letters have been delivered. The total expense of our event was \$174.60 and Nick will be requesting the \$100 reimbursement from RCONA.

New Business

"Boo" Event Budget: Colleen said this year's expense will likely be in the \$40 range for eight "Boo" baskets because Marilyn and Colleen don't have supplies remaining.

Nick motioned that we budget \$50 for eight "Boo" baskets. The motion was seconded and voice vote passed unanimously.

Garage Sale Date: Discussion on a possible spring date for our Fifth Annual Neighborhood Garage Sale was tabled until next month when all board members are present. After a brief discussion of dates, May 2 may be a good possibility. Our goal is to announce a date in our December newsletter. Colleen will connect with Stephen Costello regarding the status of his newsletter and garage sale sponsorship.

New Neighbor Welcome Packet: Colleen contacted Robert Sanchez to ask for additional Roseville Electric bags. She also asked who we could get updated Roseville publications or flyers from. Colleen will provide an update next month as to what is currently available.

Crestmont Elementary School Wish List: Nick reported that Mrs. Farmer would like the Expo markers that we have donated the last two years. Nick will order and deliver the markers.

Colleen motioned that we purchase Expo markers as our Crestmont Elementary School appreciation donation up to \$150. The motion was seconded and voice vote passed unanimously.

Other Business Not on the Agenda: At the last RCONA meeting, Colleen learned that catalytic converter theft is on the uptick now, but businesses that have provided the etching in the past are not currently offering the service. Also a Roseville Urban Forest Foundation community forester (Lisa Wilson) was at the RCONA meeting and was offering to speak at NA meetings. Colleen will contact Lisa for more information.
