The Roseville Coalition of Neighborhood Associations (RCONA) and the City of Roseville are cosponsoring a city-wide neighborhood cleanup. Join us on **Saturday, May 20th**, in making Roseville a cleaner city! Environmental Utilities will be bringing 20-foot dumpsters to Maidu Park. Residents can bring their junk between 8:30 a.m. and 2:30 p.m. (or when all dumpsters are full) at no charge. ### What will volunteers do?

- Direct traffic to the actual dumping bins--keep the lines organized.
- Check that participants can show Roseville address identification (driver's license) and collect their voucher. This event is being paid for by the City of Roseville and only Roseville residents may participate in this service.
- Make sure participants have reviewed the signage posted on-site or flyers/information for items not allowed to drop off.
- When needed, assist with unloading into dumpsters, especially for senior citizens. A volunteer waiver form will be required of all volunteers. All minors must have a waiver form signed by a parent. Request a form by emailing [treasurer@rcona.org](mailto:treasurer@rcona.org).

**The date is Saturday, May 20th.** The shifts are: 7:30 a.m. – 10:30 a.m., 10:30 a.m. – 1:00 p.m., or 1:00 p.m. – 3:30 p.m. If a volunteer would like to work multiple shifts, that would be even better! ## Free Medication Take Back Day

National Prescription Drug Take Back Day is **Saturday, April 22nd, from 10 a.m. to 2:00 p.m.** Roseville's two drop-off locations are Maidu Community Center (near indoor soccer arena) and Sun City Roseville (7050 Del Webb Boulevard). Gather up your expired and unneeded medications and drop them off for free. Vape pens and e-cigarette devices are included if you've removed all batteries. To protect your identity and privacy, scratch out any identifying information before disposing of containers. Together we can help prevent and reduce any medication misuse and help safeguard our waterways.

Although we have seen plentiful rainfall and an even healthier snowpack so far this year, drought in California remains. In accordance with Statewide regulations, starting March 1, watering days shifted to two days a week.

Customer	Time of Year	Watering Days	No Irrigation During
Residential	1st day of March – last day of April	Monday and Friday	10 a.m. to 8 p.m.
All	Drip irrigation is exempt from watering day restrictions.
