The meeting was called to order by President Colleen Cole at 7:00 p.m.

Meeting Minutes: Julie reported that the minutes of the January 10, 2023 board meeting were approved by the board members via email. Colleen ordered them to be placed on file.

Treasurer's Report: LaRon reported no change in the balance since the last report: \$2,690.94.

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer attendance was canceled by Colleen due to anticipated parking issues.

Neighborhood Garage Sale: Colleen asked the group if SCNA should hold its garage sale on the same day as Maidu's garage sale which is scheduled for April 29. Given the limited amount of time to prepare for an April event, a decision was made to hold the SCNA garage sale in fall 2023.

Roseville Spring Cleanup: Colleen reminded the group to sign up to volunteer for Roseville's Spring Cleanup scheduled for May 20 and to look for voucher information in their utility bill. A voucher and driver's license are required to verify Roseville residency.

Crestmont Park Refresh: LaRon reported that improvements were made to the restrooms and three blue benches were installed. The city has ordered additional benches and picnic tables.

Budgeting Goals: LaRon recommended the donation of whiteboard markers to Crestmont School. The board approved an amount of \$200.00 to purchase the markers. Colleen recommended that the amount of money SCNA donates to the RCONA scholarship fund be increased from \$100.00 to \$ 200.00. The recommendation was approved.

Guest Speakers for General Meetings: The group reviewed previous suggestions for guest speakers. Four potential speakers were identified. Colleen will call the individuals to find out who is available to attend the general meeting on May 9.

SCNA Website: Colleen reported speaking to the website developer. A \$100.00 payment to the developer is required before any work can begin to improve the function of the website. The board approved a payment of \$100.00.
