Board Meeting Minutes
November 14, 2023 at 7:00 p.m.
Crestmont Elementary School Media Center

Present: Colleen Cole, Paul Dickey, LaRon Golden, Stephanie Oliver, Officer Michael Keck and Candace and Michael Massey

The meeting was called to order by President Colleen Cole at 7:00 p.m.

Meeting Minutes: The October 10, 2023 General Meeting Minutes and Board Meeting Minutes were both approved by email with one change. Colleen ordered them to be placed on file.

Treasurer's Report: LaRon reported:

- October beginning balance is \$2,442.23
- No bank activity in October so ending balance is \$2,442.23

Reports/Old Business

Roseville Police Officer Neighborhood Report: Officer Keck reported our neighborhood has no emerging crime trends to be aware of. Protect yourself from phone and online scams. Theft increases during the holidays so don't leave anything of value in your vehicles. Roseville Police Department provides extra enforcement through the holidays at shopping centers. Officer Keck answered various questions from attendees. Paul shared a recent experience he encountered with a drone operator at Crestmont Park. A few days later, the same man parked in the neighborhood intending to use his drone over homes. Officer Keck said the FAA regulates how high and where drones can be used, but you may call the Roseville Police Department non-emergency number if you feel the activity is suspicious.

Roseville Firefighters: No firefighters able to attend.

Crestmont Park Refresh: LaRon gave an update on the City's progress with benches, tables and a new cement park sign to be installed. In addition to these improvements, SCNA has a goal of donating a cement bench in a shady area. LaRon provided everyone with a Crestmont Park map showing two possible locations for this bench. The cost is \$2,000 including installation and a plaque. She also provided an email from Brian Castelluccio with the City's steps to follow and a link to order the bench from. LaRon encouraged everyone to review these documents and come back in January to vote whether or not to move forward with this goal.

New Business

2024 Meeting Frequency and Day Change: Colleen reported that our 2024 board voted to meet at least four times a year on Wednesdays from 7:00 p.m. to 8:00 p.m. Here is the current schedule which is subject to change as necessary:

Items Not on the Agenda: An inquiry about the SCNA website being under construction was brought up. Everyone agrees it has been a long, frustrating process. Colleen will continue to follow up with RCONA's website designer and board members. Also, a neighbor volunteer that Paul recommended has been providing additional website support.
